

DBS「神搶手」有獎遊戲的條款及細則:

- 1. DBS「神搶手」有獎遊戲(「**活動**」)由 2022 年 9 月 21 日上午 10 時至 2022 年 9 月 28 日晚上 11 時 59 分止(香港時間)(「**推廣期**」)舉行。
- 2. 任何有意參加此活動的人士(「**參加者**」)必須符合以下條件方可參加一次抽獎(「**抽** 獎」):
