

“DBS X OpenRice: Tasty Crazy Deal” Terms and Conditions:

1. “DBS X OpenRice: Tasty Crazy Deal” (the “Promotion”) is only applicable to the principal cardholders (“Cardholders”) of DBS Credit Card and Co-branded Cards (excluding DBS Black American Express® Card and Business Card) (“Applicable Credit Cards”) issued by DBS Bank (Hong Kong) Limited (the “Bank”).
2. The entire promotion period of this Promotion is from 2 December 2024 to 26 January 2025, both dates inclusive (the “Promotion Period”), and is divided into weeks as follows:

Upon a single net spending of HK\$450 or above in Hong Kong dollars for vouchers with the Applicable Credit Card via OpenRice mobile app/website (“Eligible Transaction”) during Promotion Period, Cardholders shall be entitled to a HK\$100 instant discount (“Offer”) during check out. 150 quotas are available per week on a first-come-first-served basis.
