

"Spend with DBS COMPASS VISA to win tickets of 《ACCUSEFIVE 1st Live Tour AROUND THE NEW WORLD IN HONG KONG》" Promotion Terms and Conditions

- "Spend with DBS COMPASS VISA to win tickets of 《ACCUSEFIVE 1st Live Tour AROUND THE NEW WORLD IN HONG KONG》 " ("Promotion") is applicable to the principal cardholders ("Cardholders") of DBS COMPASS VISA ("Applicable Credit Cards") issued by DBS Bank (Hong Kong) Limited (the "Bank").
- 2. The Promotion Period is from 18 October to 20 November 2024, both dates inclusive ("Promotion Period").
- 3. To participate in this Promotion, Cardholders must complete the registration process successfully and being given a reference number upon successful registration during the Promotion Period via DBS Card+ mobile application ("DBS Card+ app") ("Successful Registration") and accumulate "Eligible Spending" (as defined in clause 4 below) with the Applicable Credit Card within the Promotion Period. The top 145 Cardholders with the highest amount of accumulated Eligible Spending ("Winner") can entitle 2 pieces of 《ACCUSEFIVE 1st Live Tour AROUND THE NEW WORLD IN HONG KONG》 ticket ("Ticket"). Each Cardholder can entitle 2 pieces of Ticket maximally in this Promotion.
- 4. For the purpose of the Promotion, the Eligible Spendings are counted based on the transaction and are defined as follows: posted transactions that are made at local public transportation and settled in Hong Kong Dollar, and the Bank shall determine at its sole discretion whether an Eligible Spending falls into the local public transportation based on the merchant codes defined by Visa or a merchant's acquiring bank, and is determined by the Bank at its sole discretion. Local public transportation includes but not limited to taxi, MTR (Including the MTR lines and services of Airport Express, Disneyland Resort Line, East Rail Line, Island Line, Kwun Tong Line, South Island Line, Tseung Kwan O Line, Tsuen Wan Line, Tung Chung Line, Light Rail, Tuen Ma Line, Light Rail and Shuttle Bus Service), bus (all routes provided by the franchised buses of Citybus, Kowloon Motor Bus, Long Win Bus and New World First Bus), Ferry (all routes provided by the franchised and licensed ferry services of Sun Ferry, The Star Ferry and Hong Kong & Kowloon Ferry (including Island Ferry and Winnertex Ferry)) and all the Tram routes. For the avoidance of doubt, the transaction of Octopus Automatic Add-Value Service ("AAVS") (including the application fee and handling fee in respect of the AAVS) shall not be considered as Eligible Spendings
- 5. Eligible Spending accumulated in different Applicable Card accounts of a Cardholder cannot be combined when calculating Eligible Spending. If there is a supplementary card under the Applicable Card account, Eligible Spending under a supplementary card will be counted towards the Eligible Spending of the principal card for calculation of accumulated Eligible Spending amount. The calculations of accumulated amount of Eligible Spending are

- rounded down to their nearest 2 decimal places, any thereafter decimal place (if any) are not counted.
- 6. Winner will be notified by the bank on or before 3 December 2024 through DBS Card+ app push notification about the Ticket redemption details. Winner shall redeem the Ticket according to the instruction. If Winner does not own a valid DBS Card+ app account in the Bank's record during the time, Winner's eligibility will be disqualified without any notification. The Bank has no liability and will not offer any compensation in respect of any failure to receive the push notification by the Winner. Cardholders can access the winning result through the bank's website (go.dbs.com/ld_result-en) ("Bank's website") from 3 December 2024.
- 7. The computer will automatically assign available seats for Cardholders and seating request is not allowed. The exact seat number will be shown on the Ticket.
- 8. Each Ticket admits one person only. The Tickets must be presented on-site for admission.
- 9. The Tickets are only applicable to the Winners whose Applicable Credit Card accounts are valid, not in default and in good standing (as determined by the Bank at its sole discretion) when the Tickets are issued. If the status of a Winner's Applicable Credit Card account is not in good standing, the Bank reserves the right to disqualify the Winner from participating in the Promotion and/or enjoying the Tickets.

The Bank is not the supplier of the products/services or the description, photos or reference prices (if any) in relation to the products/services published in this webpage (which are intended to be for reference only). Any enquiry, claim or complaint in relation to the quality or availability of the products/services or the accuracy of any of the aforementioned information contained in this webpage shall be directed to the merchant.
