

"DBS Live Fresh Card 10 Free Trials for Flexi Shopping" Program Terms and Conditions:

- 1. "DBS Live Fresh Card 10 Free Trials for Flexi Shopping" (the "Promotion") is only applicable to the principal cardholder ("Cardholder") of DBS Live Fresh Card ("Applicable Credit Cards") issued by DBS Bank (Hong Kong) Limited (the "Bank").
- 2. The Promotion is valid from 1 January to 31 December 2025, both dates inclusive ("Promotion Period").
- 3. During the Promotion Period, Cardholders who successfully apply for 6-month Flexi Shopping Programme that charged one-off handling fee ("Flexi Shopping") via DBS Card+ mobile application ("DBS Card+") ("Eligible Application") can enjoy 10 free trials. - 4. Fee Rebate will be credited to credit card account at the time the instalment of Flexi Shopping is charged to the credit card account and shown on the monthly statement. Please note that the first instalment posted date must be within the Promotion Period to be eligible for the Fee Rebate.
