- Selected Customer Online Permanent Increase in Combined Credit Limit and Cash Out to get extra
 HK\$200 Promotion ("Promotion") is only applicable to the principal cardholders of DBS Credit
 Cards ("Applicable Credit Card") invited by DBS Bank (Hong Kong) Limited (the "Bank") by SMS or
 DBS Card+ mobile application ("DBS Card+") push notification ("Selected Cardholders"). The
 participation eligibility cannot be transferred to others by the Selected Cardholders.
- 2. Promotional period of this Promotion has been already printed on/stated at leaflet/website (both dates inclusive) ("Promotion Period").
- 3.
