DBS ATM Card Promotion 2024 October - December ("Promotion") Terms and Conditions

General Terms and Conditions

- 1. The Promotion shall run from 1 October to 31 December 2024, both dates inclusive ("**Promotion Period**").
- 2. "DBS Treasures" and "DBS Account" are Customer Segments of DBS Bank (Hong Kong) Limited (the "Bank"). "Customer Segment" means DBS Account, DBS Treasures, DBS Treasures Private Client, DBS Private Bank and any other segment made available by the Bank from time to time. In Hong Kong, DBS Private Bank is the private banking division of the Bank.
- 3. "New Cardholder" means a DBS Treasures customer or DBS Account customer who has not owned DBS ATM Card or DBS Octopus ATM Card during 1 January 2024 to 30 September 2024, both dates inclusive, AND successfully applies for DBS ATM Card or DBS Octopus ATM Card during the Promotion Period. The Bank's decision on whether a customer is a New Cardholder is final.
- 4. "Registered Customer" means a DBS Treasures customer or DBS Account customer who have successfully registered once for the Spending Rebate (as defined in Clause 20) of the Promotion via designated link from 1 October 2024 to 16 December 2024, both dates inclusive ("Registration"). The Bank's decision on whether a customer is a Registered Customer is final.

- 5. The Promotion is applicable to New Cardholders and/or Registered Customers only.
- 6. Only the primary account holder is eligible for the Promotion.
- 7. Each New Cardholder and/or Registered Customer can only enjoy the Promotion once.
- 8. The Promotion cannot be enjoyed together with the ATM Card Reward of DBS Treasures Welcome Offers of the Bank.
- 9. "Eligible ATM Card Transaction" means a local or overseas retail spending transaction completed by a New Cardholder or Registered Customer via the China UnionPay (CUP) or the Electronic Payment Services (EPS) in HKD or any foreign currency with DBS ATM Card or DBS Octopus ATM Card, or reload amount by Octopus Automatic Add Value Service ("AAVS") with DBS Octopus ATM Card.
- 10. Eligibility of any transaction for the purpose of this Promotion shall be determined based on the Bank's record. If there is any discrepancy between the Bank's record and the Customer's record, the Bank's record shall prevail.

- 11. Participation in the Promotion is subject to there being no abuse/non-compliance by the New Cardholder and/or Registered Customer, failing which the Bank will not credit the reward/rebate or where it has been credited, the Bank may debit the value of the reward/rebate under this Promotion from the account without notice and/or take such action to recover any outstanding amounts.
- 12. All reward/rebate under this Promotion will be credited directly to the eligible New Cardholder or Registered Customers' HKD Current Account or Savings Account on or before 28 February 2025 ("Fulfilment Period").
- 13. The reward/rebate under this Promotion is non-exchangeable. The Bank can replace the All reward/rebate under this Promotion with alternative rewards without prior notice.
- 14. New Cardholders or Registered Customers must maintain their HKD account, and the DBS Octopus ATM Card or the DBS ATM Card at the time the reward/rebate under this Promotion are credited.
- 15. If New Cardholder's or Registered Customer's DBS ATM Card or DBS Octopus ATM Card is cancelled or if there is abuse/non-compliance by the New Cardholder or Registered Customer before the end of the Fulfilment Period, the New Cardholder or Registered Customer cannot enjoy the Promotion. The Bank will not credit the reward/rebate under this Promotion or where the reward/rebate under this Promotion has been credited, the Bank may debit the value of the reward/rebate from the New Cardholder's or Registered Customer's account(s) without prior notice and/or take action to recover any outstanding amounts.
- 16. The Bank may change the terms and conditions and/or modify/extend/terminate the Promotion without notice. The Bank's decision is final.
- 17. Promotion information will remain accessible up to one week after the end of the promotion.
- 18. The English version shall prevail if there is any inconsistency between the English and Chinese versions.

Welcome Reward

- 19. New Cardholder who:
 - a) successfully applies for DBS ATM Card or DBS Octopus ATM Card during the Promotion Period; and
 - b) completes any Eligible ATM Card Transaction on or before 7 January 2025, will be entitled to HK\$300 cash reward ("Welcome Reward").

Spending Rebate

20. "Average Total Relationship Balance" in a month is calculated based on the aggregated value of daily Total Relationship Balance (e.g., October 2024) divided by the total number of calendar days (e.g., 31 days in October 2024). The calculation of "Total Relationship Balance" is the total assets

that a Registered Customer maintains with the Bank, whether solely or jointly. The assets include Hong Kong dollar, Renminbi and foreign currency deposits (including time deposits), Currency Linked Investment, market value of local and overseas securities, investment funds, bonds, paper gold and other linked or structured investment products.

- 21. Registered Customers will be entitled to a Spending Rebate (the "Spending Rebate") on the Eligible ATM Card Transaction after Registration and during Promotion Period upon fulfilment of the following requirement:
 - a) have maintained Average Total Relationship Balance of designated amount or above as shown in the table below from the 7th day after Registration to 31 December 2024, both days inclusive ("**Fund Counting Period**").

Terms and Conditions

2024年10月至12月星展提款卡推廣(「本推廣」)條款及細則

一般條款及細則

- 1. 本推廣由 2024 年 10 月 1 日至 2024 年 12 月 31 日止(包括首尾兩天)(「推廣期」)。
- 2. 「星展豐盛理財」及「DBS Account」是本行的客戶層之一。「客戶層」指 DBS Account、星展豐盛理財、星展豐盛私人客戶、星展私人銀行及本行不時增設的任何其他客戶層。在香港,星展私人銀行為本行的私人銀行部門。
- 3. 「新持卡人」指於 2024 年 1 月 1 日至 2024 年 9 月 30 日(包括首尾兩天)期間尚未持有星展提款卡或星展八達通提款卡及於推廣期內成功申請星展提款卡或星展八達通提款卡的星展豐盛理財或 DBS Account 客戶。本行對客戶是否為新持卡人的決定為最終定論。
- 4. 「已登記客戶」指於 2024 年 10 月 1 日至 2024 年 12 月 16 日(包括首尾兩天)期間經指定連結成功登 記本推廣的消費回贈一次(「登記」)的星展豐盛理財客戶或 DBS Account 客戶。本行對於任何客戶 是否已登記客戶的決定為最終定論。
