DBS Payroll Offers – July - September 2024 ("Promotion") Terms and Conditions

- 1. The Promotion runs from 1 July 2024 to 30 September 2024, both days inclusive ("**Promotion Period**").
- 2. "DBS Treasures" and "DBS Account" are Customer Segments of DBS Bank (Hong Kong) Limited (the "Bank"). "Customer Segment" means DBS Account, DBS Treasures, DBS Treasures Private Client, DBS Private Bank and any other segment made available by the Bank from time to time. In Hong Kong, DBS Private Bank is the private banking division of the Bank.
- 3. "New Payroll Customer" means a DBS Treasures customer or DBS Account customer who has not received payroll new funds in his/her HKD Current & Savings Account through auto-payroll services during 1 January 2024 30 June 2024, both days inclusive. The Bank's decision on whether a customer is New Payroll Customer is final.
- 4. "Designated HKD Current & Savings Payroll Accounts" means the Hong Kong Dollar Current & Savings accounts held by the New Payroll Customer with Eligible Payroll Fund (as defined in Clause 5 below).
- 5. "Eligible Payroll Fund" means monthly payroll deposit of at least HK\$10,000 received in the Designated HKD Current & Savings Payroll Account through auto-payroll services. The Bank has final decision on whether a deposit transaction is an Eligible Payroll Fund or not.
- New Payroll Customer who receives Eligible Payroll Fund in his/her Designated HKD Current & Savings Payroll Account on or before 7 October 2024 is eligible to receive HK\$800 cash reward ("Payroll Reward").
- 7. Eligibility of any transaction for the purpose of this Promotion shall be determined based on the Bank's record. If there is any discrepancy between the Bank's record and the New Payroll Customer's record, the Bank's record shall prevail.

the reward has been credited, the Bank may debit the value of any reward or other gifts from the New Payroll Customer's account(s) without prior notice and/or take action to recover any outstanding amounts.

- 17. The Bank may modify/terminate the Promotion without notice. The Bank's decision is final.
- 18. Promotion information will remain accessible up to one week after the end of the promotion.
- 19. The English version shall prevail if there is any inconsistency between the English and Chinese versions.

2024年7月至9月星展出糧戶口獎賞(「本推廣」)條款及細則

- 1. 本推廣由 2024 年 7 月 1 日至 2024 年 9 月 30 日止(包括首尾兩天) (「推廣期」)。
- 2. 「星展豐盛理財」及「DBS Account」是本行的客戶層之一。「客戶層」指 DBS Account、 星展豐盛理財、星展豐盛私人客戶、星展私人銀行及本行不時增設的任何其他客戶層。在 香港、星展私人銀行為本行的私人銀行部門。
- 3. 「新出糧客戶」指於 2024 年 1 月 1 日至 2024 年 6 月 30 日(包括首尾兩天)期間未曾透過自動轉賬出糧服務,於其港元往來及儲蓄戶口收到出糧新資金的星展豐盛理財或 DBS Account 客戶。本行對客戶是否為新出糧客戶的決定為最終定論。
