- 2. The Promotion is applicable to selected DBS Treasures customers ("**Selected Customers**") of DBS Bank (Hong Kong) Limited 星展銀行(香港)有限公司 (the "**Bank**") fulfilling all of the below requirements:
 - a. one of the first 500 DBS Treasures customers who successfully registers for DBS EASY during the Promotion Period; and
 - maintains a Wealth Management Accounts ("WM Account") of DBS Treasures with the Bank throughout the Promotion Period.
