The AGM was held at the offices of Arthur Cox LLP, 10 Earlsfort Terrace, Dublin 2 D02 T380, Ireland on 13 August 2024 at 11.00 a.m. (Irish time). The following resolutions received a sufficient number of votes to be passed:

- ordinary resolution to re-appoint PricewaterhouseCoopers as auditors of the Company to hold office for the period ending at the conclusion of the next AGM; and
- ordinary resolution to fix the remuneration of the auditors, PricewaterhouseCoopers, for the period ending at the conclusion of the next AGM; and
- ordinary resolution to receive and consider the reports of the directors and of the auditors and the accounts of the Company for the year ended 31 December 2023 and to review the Company’s affairs.
