

This **Bank Charges Schedule for Faster Payment System (“FPS”) (corporate customers)** is published to let you know the fees and charges DBS Bank (Hong Kong) Limited and DBS Bank Ltd., Hong Kong Branch (Incorporated in Singapore with limited liability) (collectively “the Bank”) levy for FPS services we provide to our corporate customers in the Hong Kong Special Administrative Region (effective date: 17 September 2018) (unless otherwise specified). These charges are specific to FPS services only and so they only apply if you use FPS services. These charges are subject to change and the Bank reserves the right to introduce service charges for FPS services not included here.
